

# NOTICE OF ADOPTION OF ORDINANCES

## EDWARDS TOWNSHIP, OGEMAW COUNTY, MICHIGAN

Please take notice that, on Monday, June 12, 2017, the Township Board of Edwards Township, Ogemaw County, Michigan ("Township") adopted the following Ordinances:

### **Dangerous Buildings Ordinance Ordinance No. O-2017-02**

Ordinance No. O-2017-02 prohibits dangerous buildings; outlines its enforcement mechanisms; and amends any conflicting Ordinances of Edwards Township. The Ordinance has the following sections and catch lines: Section 1: Title; Section 2: Definition of Terms; Section 3: Prohibition of Dangerous Buildings; Section 4: Notice of Dangerous Building; Hearing; Section 5: Dangerous Building Hearing Officer; Duties; Hearing; Order; Section 6: Enforcement Hearing Before the Edwards Township Board; Section 7: Implementation and Enforcement of Remedies; Section 8: Civil Infraction and Remedies for Nonconformance with Order; Section 9: Appeal of Township Board Decision; Section 10: Severability; Section 11: Repeal; Section 12: Effective Date, which is thirty (30) days following this publication.

### **Public Nuisances Ordinance Ordinance No. O-2017-03**

Ordinance No. O-2017-03 prohibits public nuisances; defines and prohibits public nuisances; outlines its enforcement mechanisms; and amends any conflicting Ordinances of Edwards Township. The Ordinance has the following sections and catch lines: Section 1: Title; Section 2: Public Nuisance Defined and Prohibited; Section 3: Public Nuisances Per Se; Section 4: Abatement; Notice; Civil Infractions and Civil Proceedings; Authority of Officers to Abate Public Nuisances; Section 5: Hearing; Section 6: Abatement; Costs; Section 7: Public Nuisances; Emergency Abatement; Costs; Section 8: Severability; Section 9: Repeal; Section 10: Effective Date which is thirty (30) days after this publication.

### **Civil Infractions Ordinance Ordinance No. O-2017-04**

Ordinance No. O-2017-04 authorizes the Township to issue civil infractions; outlines its enforcement mechanisms; and amends any conflicting Ordinances of Edwards Township. The Ordinance has the following sections and catch lines: Section 1: Title; Section 2: Definitions; Section 3: Municipal Civil Infraction Action; Commencement; Section 4: Municipal Civil Infraction Citations; Issuance and Service; Section 5: Municipal Civil Infraction Citations; Contents; Section 6: Establishment, Location and Personnel of the Municipal Ordinance Violations Bureau; Section 7: Schedule of Civil Fines/Costs; Section 8: Records and Accounting; Section 9: Availability of Other Enforcement Options; Section 10: Severability; Section 11: Repeal; and Section 12: Effective Date, which is immediately upon publication.
